### I. DRILLS:

Update signs on drills: (208) 572-3369 is the new burley office number. Signs have not been taken in yet. Cassia sign has been taken off. Minidoka sign needs taken off still.

Annual maintenance: The drills have been taken to Stotz. Minidoka's drill is ready to go. Ken suggested changing the hydraulic hoses to avoid injury and possible lawsuits. Discs are starting to wear and need to be replaced next year. The estimated cost for discs is \$3600 for parts only. Minidoka will look at hoses and replace them themselves. Cassia drill bolts have broken. Brent Stoker asked if we want to consider what it would take to trade the drills. There will be a point where the number of renters drop off. How long do we want to continue to rent out drills? The committee will need to weigh maintenance cost against trade cost. A lot of the acreage on the Minidoka were one time CREP acres. Talk to Stotz about trade in cost.

Winter Storage: Minidoka drill will be stored by Aaron Firth. Richard will store the Cassia drill. Brent Stoker will check on both drills after the meeting to ensure the seed tubes are properly winterized. Storage fees will be paid after winter.

II. 2017 Seed Reimbursement - (grant money is spent, match funds still in account)

Committee reviewed the two applications received for the seed rebate. One is an actual cover crop mix that is eligible. Another is a single cash crop that is not eligible. The Committee discussed rolling over excess funds allotted to the seed rebate for upcoming year. Ken suggested holding to a 2 species minimum requirement to avoid problems with people applying with cash crops. Brian Kossman motioned to award Allen Sandersen a total of \$1132.50. Justin seconded. Motion carried.

Ken suggested keeping the criteria for the seed rebate as is.

Doreen reviewed the grant.

Mark Webb motioned to extend seed rebate beyond the 3 year grant funding period. There is \$18,658 allotted for future seed rebates. Brent seconded.

### III. Grant Closure

Sharon presented the final report she submitted to NRCS.

IV. 2018 Budget: The Committee reviewed the budget vs. actual. There is no budget beyond end of the grant. Minidoka SWCD LSO reporting requires an approved budget. Doreen suggested that most of the things on the budget can be left as is. Doreen suggested budgeting \$11,000 for the Soil Health Workshop due to the growth of the event. The Committee discussed budget items such as, donations and foreseeable repair costs. Russ would rather ask for donations than charge an entry fee for the workshop. Sharon will put together a new, simplified budget and e-mail it to the Committee for approval. Drill rental income and donations will be averaged out.

Cover crop tour – The Committee discussed the cover crop tour and whether or not to include it in the budget. 2017 Tour cost was \$3000. The future budget will include \$200 for the Tour. The Committee discussed the benefits and set-backs experienced with the Tours so far. The Committee discussed how the Tour assists agency employees see things from a producer standpoint. The Committee discussed the time frame of future tours. There is a weather window. Harvest is running during the same time. The Committee discussed the possibility of hosting the Tour in September. Justin suggested a virtual tour that could be presented similar to something Rocky Mountain Agronomics has. Video clips and interviews from growers could be used to present to those producers who could not attend the tour. Madi will check with Beau and Carli on price to film the tour. Add cinematography cost to advertising – around \$1500 more to advertising. \$3000 will be the total budget for advertising.
